Minutes of Argoed Community Council meeting held on 16th April 2018 at Hollybush Community Centre.

1807 To sign the register and receive apologies

1807.1 Community Councillors present: Chairman M. Williams, A. Davies, G. Lewis,

H. Rowlands, J. Watkins and W. Williams

1807.2 Apologies were received from Cllr. A. Jones

1808 To receive a report from the Police.

1808.1 PCSO Jeff Dugmore had previously apologised for not being able to attend.

1809 To receive a report from County Councillor Walter Williams.

1809.1 Councillor Williams informed the meeting that he had attended an meeting regarding an planning application for a wind turbine at Penyfan. The Planning Committee was recommending refusal of the application. The Borough Council was due to discuss the Markham Chemist application on Wednesday 18th April. Cllr Williams said that he had met with Mr Phil Griffiths from Caerphilly County Borough Council regarding the creation of ponds and the planting of trees at the former colliery site. He had also spoken about the LINC Cymru housing project on the site. A meeting is to be set up in the near future to further discuss the proposals.

The Borough Council had agreed to be part of the City Deal. All 9 councils needed to agree to the deal. He also spoke of the 21st Century Schools new initiatives.
